#### Assembly

- (1) Turn platform deck on side. Note: Be careful not to damage the fixed, welded handle.
- (2) Line up mounting holes in the caster rigging with the holes in the caster mounting plate located on the bottom of the platform deck.
- (3) Insert the provided bolts through the holes such that the threads are on the caster side (bottom) of the deck. Place washer on the nut side and install casters.
- Note:** The four (4) swivel casters should be positioned at the four corners of the deck. The two (2) fixed casters should be mounted in the center of the platform as shown in Figure 2.
- (4) Tighten all nuts to secure the casters.


